

## Methodology



 EY 2020 Global Integrity Report was published in June 2020.

- Between January and February 2020, our researchers

   the global market research agency Ipsos MORI –
   conducted 2,948 surveys in the local language with
   board members, senior managers, managers and
   employees in a sample of the largest organizations
   and public bodies in 33 countries and territories
   worldwide.
- A further 600 surveys in total were conducted in April 2020 using the same respondent profile across China, Germany, India, Italy, the UK and the US during the COVID-19 pandemic.
